Tuition is due the first day of each session/month. There will be no refunds or exchanges of tuition, costumes, or dance related fees from one person to another. A \$25.00 late fee will be applied if tuition is not paid at the onset of the session. A \$45.00 fee will be charged for all return checks. Class placement is entirely at the discretion of the director.

Full tuition will be charged regardless of holidays or missed classes (holidays are built into the rate). Make-up classes are available at the discretion of the director. There will not be any make-up classes offered after March 1st due to recital preparation. Private lessons are available upon request. See studio director for more details. Costume fees for recital are due November 1st. Children sizes are \$105.00 and adult sizes are \$115.00. If you do not pay for your costume, it will not be ordered and your child will not be permitted to perform in the recital. If your account becomes 90 days past due and legal action is taken, you will be required to pay any and all attorneys fees related to your case/account.

I recognize the potential for injury in physical activities such as dance and gymnastics. Being fully aware of these dangers, I voluntarily give consent for my child/children to participate in all Jewels Dance programs and accept all risks associated with participation. I, on my own and my child's behalf (and all respective successors), forever release Jewels Dance and all staff of said establishment from any and all liability and damages associated with any injuries incurred while my child/children are under the instruction/supervision or control of Jewels Dance. If any disagreement is to be settled by a court of law, I will be responsible for any and all Jewels Dance lawyer fees, court fees and any other legal fees that may arise associated with my disagreements.
